Objectives of the Club

b) To carry out patrols in accordance with the regulations of Surf Life Saving (WA) and provide the necessary efficient life saving equipment.

c) To co-operate with other organizations in enforcing life saving methods and equipment.

 d) To educate the public surf awareness and current resuscitation procedures and encourage members of the public to gain awards as permitted by Surf Life Saving (WA).

e) To partake in competitions and events in all surf life saving areas and other areas permitted by Surf Life Saving (WA) and to sponsor members to complete.

f) To co-operate with the Town of Cottesloe in possible improvements to beach facilities.

In Addition:

a) To acquire by purchase, exchange or otherwise whether for an estate in fee simple or for any less estate lands and tenements or real personal property or any tenure thereof, whether subject or not to any changes, or encumbrances, and to erect, replace, maintain, reconstruct, adapt and furnish any offices, buildings, or lands, tenements or property or any part thereof after approval by a Club General Meeting.

b) To borrow any monies required for the purpose of the Club upon such terms and conditions as may be determined and for that purpose to mortgage, pledge or otherwise charge any real or personal property of the Club.

c) To invest funds of the Club, when available, providing that investments shall be in trustee securities only.d)To employ staff as required to administer and promote the objectives of the Club.

e) To do all or any of the matters authorized either alone or in conjunction with any person, company or unincorporated body through any factors, trustees or agents.

f) To do all such things as they appear to the Club to be incidental or conducive to the attainment of the foregoing objectives or any of them.

Vale -

OSWALD (OSSIE) YEOMANS

27th February 1932- 8th October 2021

Oswald (Ossie) Yeomans at the time of his death was the clubs oldest Life member.

Barman extraordinaire on a Sunday afternoon over many years, last opened the bar on a Sunday in 2016

First Juvenile to join the club in 1936, when the category was first established, he obtained his bronze no.14860 on 2nd April 1939, he was presented with his 70year service medal in 2009 and 80year service medal in 2019. State title winner on numerous occasions in beach sprints and beach relays with the likes of Geoff Brown, Tom Myles and Danny Dunn.

Was part of the committee set up to establish the building we now all enjoy.

Served the club as Captain and Secretary over a number of years (this insert text from premier Club sums up Ossie) "Gaston's club captain was Ossie Yeomans. He also served in the war as a youngster, but there his similarities with Gaston ended. One was a swimmer the other a beach sprinter. Gaston had a forceful, driving leadership style, a man who bulldozed toward his goals, Yeomans, far quieter, did things his own way.

Several contemporaries described him as being a tough little fellow who preferred persuasion in operating on the beach. Not particularly interested in women, his life revolved around getting his club firmly on its feet again, or drinking in the front bar of the Cottesloe hotel. By all accounts he was a very successful captain, speaking his mind whenever he felt the need. One can gauge his impact from the fact that he was Captain for four successive seasons, during which the club flourished" he was part of the successful Don Morrison era as a member of his reel team.

Served his country during the second world war over the years 1942-1945 in the AIF stationed at Labu Lagoon near Lae in New Guinea supplying war cargo to the bases, with the Water Transport Division of the Royal Australian Engineers 43rd Landing Craft Company obtaining the rank of Sergeant.

Ossie courted and married a member of the ladies' surf club Beryl Cain at St. Luke's Cottesloe the union producing three children Joanne, Leonie and son Tracey, seven Grandchildren and eleven Great Grandchildren.

Vale OSWALD (OSSIE) YEOMANS 27th February 1932- 8th October 2021

Born the third son of Fred and Irma Yeomans in Cottesloe he joined brothers Keith and Colin.

Ossie did his primary schooling at Cottesloe and then attended Fremantle Boy's. His working life commenced as a clerk in Fremantle along with assisting Keith in his garage in Eric Street Cottesloe, he joined and worked for T&G Insurance for many years. Crayfish Processing at Robbs Jetty (much to the delight of the family as the cray legs arrived at home each day), Garden City Security Officer for 10 years and following his retirement he Volunteered, as the bus driver for Our Lady of Fatima School Palmyra (morning pick up and afternoon drop of) until age 75.

Nothing seemed to hold him down as beside the work and his bus driving, he found time to volunteer for neighbourhood watch, was an active member of Aussie Melville Swimming club. Ossie had many interests and hobbies he performed small woodworking projects, was a keen painter and sketch drawer of some very fine pieces. On top of all this he was a very keen Potter and sold much of what he produced, through an outlet in Cottesloe, how he found time for it we must wonder, he was also an avid reader and kept his mind sharp by doing crosswords, truly a man of many talents.

It was not all work as he and Beryl enjoyed trips to Hong Kong, Singapore and Bali several times. Ossie was the preverbal sportsperson, 1941 Junior Shot Put champion, Hockey with the Fremantle Hockey club, before and after the war and of course his participation as a member of Cottesloe Surf Club.

He also featured in the columns of The West as he was spotted, walking his dog alongside the river collecting rubbish and disposing of it, by the neighbours who dobbed him in to The West and they featured him in an article, as well he was featured going for his driver's licence test at the age of 90. (He ceased driving at 98)

As a final gesture to his fellow "Vets" Ossie left \$500 in his will for the "Vets" to have a drink on him. To say the "Vets" have lost a true champion is an under statement and we extend our deep condolences to his family

PETER STANLEY GOLDTHORPE

29th January 1941- 24th November 2021

Peter Goldthorpe was truly a man of the sea - a champion surf lifesaver who spent the greater part of his life swimming, surfing, fishing, ski paddling and teaching others the vagaries of the ocean. Nothing escaped his gaze as he scanned the sea and shoreline, whether it was the swell, chop, drift, size of the breaking waves, underwater sandbanks - all were absorbed. The beaches between Swanbourne and Cottesloe were his haunt for almost 70 years, so much so that he was a seamark, like the Cottesloe pylon.

Son of Harry and Marjorie Goldthorpe, Peter was born in 1941, nine years after his brother, John. He attended East Claremont Primary School, and later when the family moved to Wood Street in Swanbourne, the nearby primary school. There his prowess at cricket and football soon stood out, however while riding his bike to trails for the State schoolboys' cricket team, he had an accident, losing his front teeth. End of trails, and origin of his later nickname, "Choppers". Others knew him as Goldie. By the time he began high school at Fremantle Boys' School, Peter was a promising swimmer. In 1954, he joined the Swanbourne-Nedlands Surf Life Saving Club as a juvenile (under-14) member. Recognising his talent, the club paid for him to be trained at Claremont Baths by Jack Hughes, who soon knew he was coaching a future champion. By now, Peter spent summer and winter at the beach, he and two mates mastering and body surfing the winter swells.

The yearly rhythm of life for the three was, summer - surf club swimming races and carnivals, autumn - fishing for herring, winter - surfing and playing hockey. Fishing was mostly at North Cottesloe however occasionally the trio would ride rods in hand to the North Mole. Having no luck, they would fish until nightfall, then seek a train ride home in the guard's van, the guard's usual greeting being, "Ah, boys - a wet arse and no fish?" Mostly he was right! However it, was rare in later life that Peter not bring home a catch, summer or winter.

Vale

PETER STANLEY GOLDTHORPE

29th January 1941- 24th November 2021

By his mid-teens, Peter was on the way to becoming a champion surf swimmer, demonstrating this by winning cadet (under-16) and junior (under-18) surf and belt race State championships between 1957 and 1959, as well as being selected in Surf Lifesaving WA's 1959 State team.

In 1961, now a senior competitor, he still retained boyhood pleasure of winter surfing: he and several fellow members persuaded the Swanbourne club to allow them to spend chilly Sunday afternoons rowing an old, heavy wooden surf boat to Cottesloe and spending hours catching waves. Peter, who stroked this motley crew, always left the beach with his false teeth carefully placed in a small wooden box, which in turn was enclosed in a plastic bag containing two apples, the stroke's sustenance for the afternoon!

At the beginning of the 1961-62 summer, he transferred to the Cottesloe club, where he enjoyed his greatest success. Strongly built and imposing, in that decade he proved to be a powerful rough water competitor who won both surf belt and surf race championships, the only swimmer to do so in the 1960s. In addition, Peter was a member of four State champion rescue and resuscitation teams in 1962, 1963,1965 and 1967. In 1963, he also won the Australian championship, a rare victory for a WA team. Cottesloe, with Peter included, also won three surf team championships. Not surprisingly, he was included in five State teams in the 1960s, being captain in 1968.

Peter was also a tireless worker for the club. Popular with his fellow members, after three years as vice-captain in 1965 Peter was elected captain, controlling all beach activities, including all patrols and competition. He held the position for six years, the equal longest term in the club's history. John Barrington recalls that he was conscientious and tireless, ever present organising older members on the beach, as well as training juniors and cadets in surf swimming and team events. Peter rightly realised that from among them would come the club's future leaders.

After leaving school, Peter eventually became chief clerk in the engineering department of the City of Perth, retiring in 1995. Away from the surf, Peter's life revolved around his family; he and nurse Mary Murdoch married in 1968 and had two children, Davina (born 1973) and lan (born in 1975). Besides his beach activities, Peter enjoyed playing hockey, captaining the Cricketers A3 team for several years. He was reliable in the backline from where he could encourage teammates, and employ his powerful clearing hit.

Retirement led to a second, 20-year part-time career as an instructor at vacation swimming classes, at different times at, Fremantle, Cottesloe beach and Lancelin. Children in his Cottesloe classes recall that they were taught far more than how to swim: the informal Goldthorpe curriculum, sternly imparted, included understanding changing weather and sea conditions, different wave types and how to negotiate them, plus surf awareness. Those in his classes have never forgotten his teachings.

Throughout his life, Peter's days included swimming and fishing, while in more recent years he was also a caring grandparent. Perhaps it was inevitable that when his grandchildren joined the Swanbourne club's nipper program, he would return to the beach where he first mastered the challenges of the surf.

Peter was an outstanding surf lifesaver, but as Paul Gerrard, who was coached by him, recently observed, he was much more - a principled man, inspiring, selfless, honest and straightforward. He left a legacy that will long be remembered.

9. General Business

Kim Welch formally thanked and acknowledged the building committee, led by Mike Franz, for their significant work and contributions to date. He advised that a new building committee would now be driving the building project chaired by David Craig, and including David Ellwood and Kim Welch.

Kim updated the members on progress of Indiana Teahouse development including provision for a new boatshed, along with a continued dialogue with Fiveight.

1. David Roper suggested purchasing more cardio gym equipment for the club gym, namely a cross trainer and treadmill.

2. Peter Rattigan raised the issue around potential upcoming carparking changes/loss of the car bays along the Cottesloe foreshore, and asked if the club was in dialogue with the Cottesloe Council. Ben Stephens replied that whilst this was in the hands of the council, the club was in regular dialogue with them over such matters. Jim Laurenson asked what the provision was for developing more parking at Napier Street, which was the alternative proposal to alleviate loss of parking bays elsewhere. Ben Stephens replied that the club was aware of this, and the valid concerns around distance from the beach which did result in some drop off zones; although not really quantifiable at the moment in terms of exact impact, the club will continue to build on its relationship and dialogue with the council.

3. Peter Kuhne raised a concern regarding patrolled hours extending until 6.00pm on weekends, citing the impact of the longer shift on younger members particularly with regards to their study etc. Felt it was a waste of time and that 5.00pm would be a more appropriate time to close patrols. Ben Stephens acknowledged this concern and explained that this had already been flagged following a debrief from the previous season, and would continue to be reviewed in line with the provision of necessary lifesaving support to the community.

4. Ben Stephens extended the club's thanks to Marg Bond for all of her work in the organisation and preparation for the AGM.

5. Kim Welch extended thanks to Ben Stephens on behalf of the management committee for another season as President of the club. He acknowledged the time and effort Ben invested into the wellbeing of the club and expressed his confidence in the club's direction under Ben's continued leadership.

5. Ben Stephens called the meeting closed, and in club tradition, declared the bar open.

Dear Members and Supporters,

It is with great pleasure I present this 113th Annual Report of the Cottesloe Surf Life Saving Club (Inc.) on behalf of the Management Committee for the 2021/22 season and again note no lives were lost during our patrols at Cottesloe Beach.

"One of the tremendous skills you learn as an active surf life saver is that of resuscitation. Together with the other 'R', of rescue, we have both the indelible image of surf life saving – the R&R drill – as well as our two most fundamental skills. Yet over the life of the movement our approach to these skills has not remained static, new approaches have been developed and new methodologies have evolved. There has been change."

"Much of the effort of the last two years has been to introduce members who have never previously held a position in the Club, perhaps in any organisation, to the role of an office bearer. In doing that, I have considered it my role to act as a bit of a 'windbreak' and provided a backstop to the myriad of tasks so that the new office bearer has time to 'take root' and not get washed away in the storms that can be Club life. In some cases, the right role has been identified and we have seen the roots shoot out. In others, perhaps a transplant was needed to a location with more sun, but they live to fight another day – perhaps slightly over fertilised."

"An annual report is an interesting document in that it acts as a communication to current members at the conclusion of a season and provides a historic record from which at 'somewhere ages and ages hence' we may look back, review with a sigh the paths we have, or have not, taken as a Club."

"While the last 18 months can undoubtedly be described as a difficult period for the Club, I am heartened by the resilience that ensured we stayed positive, focused on our objects and delivered a season where no lives were lost on Cottesloe Beach."

"Look back on my past President's Reports I've started this missive previously with references to the Pareto Principle and a graph of sustained management experience; a metaphor of windbreaks, taking root and over fertilisation; and even a Robert Frost poem with accompanying stained metaphor on 'negativity infection'. Turns out timing is everything when it comes to virus metaphors."

A President Report

So each of my President's Reports has started. I figure if influencers are deliberately rewearing outfits on Instagram in the interests of sustainability recycling a bit of prose can't be a bad thing. Outside of being in my head (not advised) assembling these snippets of my President's Reports is a relatively easy way to highlight the narrative of my time(s) as President over the last ten years.

It started with the identification of the need for change and highlighting our most notable successes have been achieved when we have consistency in management. It then focused on team building and introducing people to office bearer roles in the Club, hopefully in a way that is thankful for their contribution and doesn't burn them out. The narrative did get a little abstruse with the poem, but in essence was stay positive (and don't be an asymptomatic carrier of negativity), don't over analyse and try to reduce decision loops to as close to the front-line as possible.

Presidential narrative part 2 highlighted that it's how a system performs at its worst that can be most illustrative and it is important for us to take our inherent resilience and build it into our Club systems. The final part of the narrative is 'Lock it in Eddie' - the move into the structure changes and codifying how we are doing things in writing.

Possibly the best example of 'locking it in' is the relaunch of an up to date strategic plan, that is a product of General Manager, Kim Welch, external consultancy form Shape Management and the input from office bearers who have spent multiple years in their roles, with particular leadership from Peter Ferguson, drawing it all together. The aim is for this to be a living document that benefits from the debriefs we conduct after each season but now the narrative, or vision, we are working to is clear. When ideas are proposed or resources sought

they can now be tested against the strategic plan and if they further those objectives then it will be clear why they were approved.

At a more mundane level the strategic plan is often a requirement for grant requests when seeking funding for building works, so the document will also help in this space too. The Building Committee of David Craig, David Ellwood, Peter Ferguson, Kim Welch and myself met regularly to consider funding pathways and other concepts that may be feasible for the space, at the same time staying true to the central principle of being a surf club first and foremost.

It does seem I have a propensity to refer to the 'overwhelmingly positive' reports from the officers in annual reports, and this document is no exception and I commend their reports to your review. Another 'overwhelmingly positive' sign of where the Club is positioned was the attendance at the Annual Dinner. The event was not just populated with club stalwarts, always great to see, but three tables representing the Woodside Nipper Parents. Even more positive was the calibre of the award finalists and winners – representing such a cross section of the Four Pillars of Surf Life Saving.

Another great signal that we are on the right path was the senior club competitors taking out the Handicap Trophy at the 2022 Senior State Championships. It is a great signal because it's based on improvement over a number of seasons not just from one year to the next. This is a huge endorsement for all the hours the coaches and before them age group managers have put in to helping these competitors get the most they can out of surf sports. Congratulations must also be extended to our Club Co-Captains, Karlene Craven and Gemmaley Walsh, who have worked together as a great team to bring much needed enthusiasm and focus to surf sports!

In addition to the presence at the Annual Dinner, the Woodside Nippers part of the Club are also a presence on Sunday mornings. Participation has gone from strength to strength and its always great to see the organised chaos that is Sunday mornings. Thanks to Julian Barry and his team of Age Group Managers, coaches, supporters and parents for running one of the best Woodside Nippers programs on the coast, and for also stepping up and supporting Club fundraising and social activities across the season.

Deb Dean provided another huge effort as Life Saving Officer and lead from the front in tackling the many challenges of that portfolio. Thanks to your team, very much at the coalface of our lifesaving services offered to the community.

Thanks to Courtney Franz who finishes her second year in the Education role and steps down to plan a wedding, congratulations! Courtney made some real in-roads into setting up a standard education calendar, and with Deb Dean really brought the focus back to the role of proficiency in skills maintenance. It would be great to see more members get involved in training – it is a very rewarding area of the Club, so if you can get involved, even in a small way, let Kim know!

Thanks to Garth Walter for stepping into the Youth Development portfolio, his experience in managing covid responses in other organisations, together with strategic planning and risk management experience was a welcome addition to the Committee.

Thanks to Administration of Kim Welch and Anna Walter. It's quite possible for every one thing that you see being done there are another five activities on the go.

Outside of the Management Committee I'd also like to thank a few members whose names have been constant over the last ten years. Firstly Marg Bond, for the most part in the office, but also popping up on the awards committee, foundation committee and annual dinner committee over the years! Owen Ashby, a bed rock in the Café and Paul Gerrard as Cottesloe Mile Coordinator. Robert Watkins and the Veterans have also been a constant over the last ten years, their membership popping up to support the Club at a moment's notice.

Finally, thanks to Peter Ferguson for what he has undertaken in the Treasurer role this season and has previously undertaken as the Club Captain. Peter has a depth of experience both in and outside of Surf Life Saving and so I also thank him for taking on the role of President for next season and wish him and his Committee all the best!

Streasurer Report

As a headline, with Total Cash Resources of \$1,025,091 it is pleasing to report that our Club has this year achieved, and exceeded, its long term target of \$1,000,000 total cash by 30 April 2022. This is a resounding acknowledgement of the planning and management of our Club's investment strategy and Foundation. This year the Foundation cash also increased to \$757,853 and these very strong and healthy cash balances will sustain the Club well into the future.

In another year where our Club was affected by Covid measures it was a significant achievement that we maintained a surplus for the fifth consecutive year, and our overall financial position again strengthened significantly. This was despite the Job Keeper subsidy of \$66,000 and the Non Taxable Cashflow bonus of \$10,000 ending in the prior financial year which, when comparing the FY21 surplus of \$71,212 to our surplus this year of \$20,721, underscores the strength of our financial results (including taking into consideration the impact of Covid restrictions, depreciation of assets; movements in stock levels, and timing of sponsorship revenue and receipts).

As stated in previous annual reports, total available cash is the most important financial number and measurement for the Club and will drive the Club forward. Some key numbers for our Club, are:

There are a number of reasons for the above results, including increased membership numbers with a record 1417 members, which is a 5% increase from 1348 in FY21, and 14% higher than our FY20 total membership of 1244. Membership fees year also increased 15.7% to \$188,180.

Some other areas worth highlighting include the Bar which saw a substantial increase in Income, up by close to 100%. A number of large events contributed to this and a significant increase in profitability. The Café continues to be well managed and very profitable, the Apparel Shop sales increased, however costs and mark downs also increased.

Friday night activities continued to be popular, as were several 'Sunday Sessions', and the Cottesloe Mile was again a highlight of our calendar, and a financial success.



Another highlight of the year was, as in prior years, the fundraising effort during Sculptures by the Sea. Over the course of this event, good financial gains resulted for our Club, and of equal importance feedback continues to be that this event, which involves all areas of the club from Nippers to our Vets, is as popular with members as it is with the Public.

A final note is the positioning of our Club for growth now and into the future. Our strong financial focus and discipline is producing results and underscores our Mission and Vision in our Strategic Plan, our Building Redevelopment planning and most importantly the ongoing development of our strong Club culture.

SPerpetual Foundation

The Perpetual Foundation Fund consists of donations and bequests from generous people in the Community who support our vital volunteer work to ensure our iconic lifesavers can continue to save lives on the beach. As Chairman, I report that the Trustees of the Foundation, consisting of Robert Watkins, Margaret Bond, Bruce Simpson, Benjamin Stephens and myself, met twice during the year. This year, there were no changes to the Trustees of the Fund. The role of the Trustee is to manage and administer the Fund and I thank these members for their contributions during the year, especially Margaret who researches the various investment options to be passed on to the Management Committee.

Funds with AMP Bank & ME Bank were rolled over for the same term this past year to obtain the highest interest rates possible at the time. The investment with ING Bank was redeemed at maturity due to the marked decrease in interest rates with that financial institution. The Trustees have recommended the funds be invested with another financial institution, My State Bank, which has been approved by the Committee. Paperwork is being completed at this point in time. Whilst rates have been steadily increasing since Covid-19 times, the term of this new investment has been reduced to a term of 11 months to allow for the maximum rate possible and to allow for the fluctuations in interest rates expected within the next 12 - 24 months.

As per the Constitution, funds are invested in authorised deposit-taking institutions (ADI) that are covered under the Australian Government Financial Claims Scheme (FSC). The FSC is a government-backed safety net for deposits of up to \$250,000 per account holder, per ADI, in the unlikely event that one of these financial institutions fails.

I am happy to report the Fund cash in bank balance as at 30 April 2022 was \$272,187.71 (which included redemption of the ING Term Deposit (\$258,064.00), interest from all Term Deposits, Interest on the bank accounts plus donations). Four Term Deposits totalling \$485,705.37 are held on behalf of the Foundation at present. Therefore, total funds held on behalf of the Foundation as at 30 April 2022 were \$757,893.08.

Donations from our generous Donors and Cottesloe Veterans (\$5K) totaled \$9,855.00 this year. We would like to take this opportunity to thank our valued supporters for their generosity & ongoing support to the Club &, in particular, the Foundation. We would also like to thank the Club for their support over the years and whilst they were unable to transfer funds to the Foundation again this year, the support from Management is still recognised and acknowledged.

It is important that members are aware that, as a Perpetual Fund, the capital is preserved. In line with the Constitution, the Club's Management Committee can only access five percent of the amount standing to the credit of the fund at the commencement of the Club's financial year. Barring this, the consent of the majority of members present and voting at a Special General Meeting is required to access funds in excess of this percentage.














Members patrolling: Hours patrolled: Preventative actions: Rescues: **4**



For those members who love their statistics, the above provides a snapshot of our season and reflects a similar trend to recent years, with our active patrolling member numbers flat-lining for the past few years and fewer outstanding contributions of active members with patrol hours in excess of their rostered hours.

For those members for whom statistics do not tell the story, read on!

Lifesaving Officer Report 2021/22 Season by Deborah Dean

Covid still presented a challenge for the provision of our essential services this season, with many of our patrols barely compliant due to isolation rules and regulations.

We also had an historically long hot summer, with beach attendances at record levels (despite our record-keeping not necessarily reflecting the same - I would be the last to admonish our over-stretched Patrol Captains for not rigorously documenting hourly beach attendances when our priority is always having eyes on the water, and not buried in an iPad).

So with that said I most definitely wish to thank every single member who put in even one session on patrol, as your showing up and donning the red and yellow are what defines our Club. Four rescues in a season does not tell much of a story; there are so many 'almost rescues', or quick-thinking preventative actions that are note-worthy - our fabulous summer weather combined with a frequent shore-dump meant many a toddler, or less-than competent adult was helped to their feet, or to the shore, by a patrolling member - being there, and being in uniform meant that tragedy was averted completely.

To those rescuers, and you know who you are - well done, and thank you for showing up and doing your job. You actions may have seemed modest at the time, and lacked the impact of Bondi-rescue type drama, but none-the-less they are the reason our beach is so well loved by Perth beach-goers - a safe beach, made safer by our patrolling members.



Lifesaving Report

We continue to maintain fourteen patrol teams and a roster system, which works reasonably well, but is only possible because of the efforts of our Patrol Officer. Paul McCarthy does a fantastic job here coordinating 14 patrol teams over a season to end up with a fair allocation is an extremely difficult task and one that was handled efficiently and with nary a peep from our Patrol Captains - definitely a sign of a job well done - thank you Paul. Sharp-eyed readers will note the use of the present tense regarding Paul's position - definitely need his skills for another season or two!

Paul also covered for our short-comings without a specific event officer - it seems our calendar fills up with additional obligations and expectations and as always, whilst we both had late nights stressing over our ability to provide water safety for events such as the Cottesloe Classic Mile, Open Water Swim series, and Rottnest Channel Swim - let alone Public Holidays - the smiling faces of our patrolling members would greet us in the early mornings and all of these events went off uneventfully, which is exactly our aim from a lifesaving perspective.

Special mention must also be made of our IRB co-coordinator (with Bree Jenkin), Patrol Captain and patrolling member extraordinaire, Dom Lawrence, for another exceptional season, now taking on training IRB crews and drivers, as well as continuing to add to his laundry list of lifesaving gualifications (need rock rescuing anyone - Dom is your man!). As a Club we can only hope that his new position with the WA Police Force does not impede his volunteer activities too severely, as he covers more bases than Babe Ruth hitting home-runs and we will be hard-pressed finding volunteers with his skillset and commitment level. Thank you Dom, and no, I'm not just saying nice things about you in case I get picked up for speeding!

One skill that Dom hasn't yet picked up is that of the fine art of Drone Operations, and this season we have been able to consolidate our drone operations (once SLSWA deigned to provide us with an operational drone - not quite sure how Covid affected the dispatch of getting said drone off a shelf at SLSWA, but apparently, it did) with the drone conducting a number of sorties every weekend of the season.

Thank you Mark Fortey for stepping up and ensuring your small group of qualified operators were up to the task. Training plans for new operators are still a workin-progress, but overall, drones are quickly becoming an invaluable tool for advanced observation and we will work on prioritising training for season 22/23.

Patrolling members who love technology, don't really enjoy getting wet, or dealing with the general public, are ideally suited to drone operations - happy to be inundated with expressions of interest for next season if you wish discuss further?



Surf Clubs Australia-wide face the same tasks and difficulties, particularly in the volunteer space, with our ever-increasing 'busy-ness' and onerous compliance requirements (another requal anyone???) leading to a nation-wide shortage of volunteers. Whilst our Club manages to fulfil our obligations, and in most cases, provide an exceptional level of service to the public, we need to look forwards and see how we meet expectations and commitments, without burning out the core of volunteers who do commit to our fundamental purpose - lifesaving. After being in this role for a couple of seasons I now have a strong grasp of what needs to be done, and a realistic idea of how - but without additional member support the workload for the few that do step up will not be sustainable.

I do hope whilst we are recovering (in all ways) from the impacts of Covid, that our collective renewed appreciation of our beloved Club community therefore translates to members considering our core function and supporting our lifesaving operations to ensure a viable future. And no, you don't need your Bronze, or to get wet - we all have different skills, and I am sure we can find a task to suit anyone!

Surf Boats A word with Jeff Burling

Welcome to Surf Boat Rowing Season for 2021/22.

The aim is to row your 210kg boat out through the swollen surf, turn around and catch a wave back to shore. But is it really that simple?

As soon as you hit the waves you realize what a precarious situation you are in. A successful boat needs two things: set and swing. Without these the boat tips back and forth and jerks front and back, making it impossible to build momentum and speed. It only takes one mistake and you are propelled from the boat In order to find the set and create swing, everyone must work together to balance the boat; and have exact timing. Your hands must be at exactly the right height as you slide up to the catch. Every oar has to drop into the water at the exact same time. Everyone needs to pull at equal pressure. All the blades need to come out of the water and release in unison. Any deviation disrupts the boat.

These skills are taught here at Cottesloe SLSC by our incredible trained professionals called Sweeps. Sweeps not only instruct the crews on the techniques needed to race but also actively steer the boat in the surf during racing. Having an experienced and well skilled Sweep can be the difference between a Gold Medal and or not finishing a race. It really is that important. A Sweep is the powerhouse behind the Surf Boat and in my 19 years as Surf Boat Captain of Cottesloe SLSC I can say that this season I am privileged to work with two of the best.

Together Paul Beattie and Stuart Turnbull have accumulated over 83 State and National Medal; both Rowing and Sweeping Surf Boats. Add this to my 100+ State and National Surf Boat Medals, we are the most experienced Team of Sweeps on the Western Australian Coast. (183+ Medals between us). It is an honor to be inspired by these men and collaborate our intensive and motivating training sessions together as a Team. I could not tell you the hours we all put in as Volunteers, but it certainly replaces a part time job.

The Sweeps here at Cottesloe SLSC offer invaluable mentorship to every rower from the Arena. Their contribution in terms of training, maintenance and competition is ineffable. The Surf Boat Arena has achieved enviable success this season winning 8 State Team Medals. Collectively 26 of our Surf Boat Rowers walked away with a State Medal this season. An incredible result both personally and for our Club.

The Open Men's Team, the Cottesloe Cookers won the Gold medal in the Short course State Championships this season. Many crews train for years to accomplish this and never succeed. The Team consisted of Jeff Burling (Sweep) Josh Gray (Stroke), Dan Hall (3), Eamon Murphy (2) and Lucas Sibma (Bow). This crew personifies feeling the set and the swing and entering a pure flow state of performance. The Woodside Nippers curriculum is comprised of 4 key learning areas – Surf Awareness, Individual Safety, Lifesaving Skills, Surf Sports Skills. Cottesloe SLSC runs the Woodside Nippers program from mid-October to late March each season. The season commences with pool proficiencies the Sunday prior to commencing beach activities, and proficiencies are held as per the SLSWA requirements for each age group.

Cottesloe Classic Mile

38th Cottesloe Classic Mile – Saturday 8th January 2002

What an exciting and successful day we had for the 38th annual Cottesloe Classic Mile on Saturday. It was only due to the contribution of our sponsors and the team work of more than 50 members that the event was such a success.

The 400m dash for about 50 juniors and novices went off without a hitch, with family and friends cheering on these mostly younger swimmers. This race follows an M-shaped course wholly within the ECO Barrier. Club talent Max Eldon was the clear winner of this event.

Some ten minutes later, the first wave of the 3km race had gone barely 50m from the beach when a shark sighting near North Cottesloe saw the patrol clear swimmers from the water, and the races were put on hold.

By the time the one hour safety window was over and the all clear given, conditions had deteriorated, and many entrants had chosen to leave. The Freo Doctor was blowing at over 15 knots, and the sea was running strongly to the north. The decision was made for safety reasons to cancel the 3km race (which would have taken swimmers south almost to Pearse St) and instead just run the 1.6km Classic Mile to North Cottesloe and back.

NOTES TO THE FINANCIAL STATEMENTS

STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES 1

The financial report covers the Cottesloe Surf Life Saving Club Inc ("the Club") as an individual entity. The financial report is presented in Australian dollars, which is the entities functional and presentation currency

The financial report consists of the financial statements, notes to the financial statements, the officers' declaration and auditors reports.

Basis of Preparation

The Committee has determined that the Association is not a reporting entity because there are no users who are unable to command the compilation of reports to satisfy their information needs. These financial statements have been prepared to meet the reporting requirements of the Western Australian Associations Incorporation Act 2015 and the Australian Charities and Not for Profits Commission (ACNC) Act 2012. These financial statements are therefore a special purpose report prepared in accordance with the measurement and recognition requirements of Australian Accounting Standards. In addition, the financial report has been prepared in accordance with the following disclosures:

- i. AASB 101 Presentation of Financial Statements
- ii, AASB 107 Statement of Cash Flows
- iii. AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors iv, AASB 1048 Interpretation of Standards
- v. AASB 1054 Australian Additional Disclosures

No other Australian Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied

(a) Accounting Policies

The principal accounting policies adopted in the presentation of the financial statements are set out below. These policies have been consistently applied to all years presented, unless otherwise stated.

(b) Revenue recognition

To determine whether and when to recognise revenue, the Association follows a 5-step process:

- (1) Identifying the contract with a customer;
- (2) Identifying the performance obligations;
- (3) Determining the transaction price;
- (4) Allocating the transaction price to the performance obligations; and

(5) Recognizing revenue when/as the performance obligation(s) are satisfied.

The Association's main revenue sources and accounting policies are listed below:

Membership fees

Membership fees is recognised over the time as the services are provided to the customer.

Bar, Café and Surf Shop Sales Revenue

Revenue is recognised when the control of the goods is transferred to the customer and payment is received.

Sponsorship Revenue

Sponsorshipr revenue Is recognised on receipt in accordance with AASB 1058 Income for Not for Profit Entities as they do not contain sufficiently specific performance obligations.

Fundraising and Club Events Revenue is recognised when the event occurs and the funds are received.

Interest Interest income is recognised on receipt

Other income and donations Are recognised on receipt.

(c) Income tax

The Club is exempt from income tax under the provisions of Section 50-5 of the Income Tax Assessment Act 1997.

(d) Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less

(e) Trade and other receivables

Other receivables are recognised at amortised cost, less any provision for impairment.

(f) Property, plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

The carrying amount of plant and equipment is reviewed annually by the Management Committee to ensure it is not in excess of the recoverable amount from those assets.

The depreciable amount of all plant and equipment is depreciated on a straight line basis over the useful lives of the assets to the Club commencing from the time the asset is held ready for use.

NOTES TO THE FINANCIAL STATEMENTS (Cont.)

1 STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The depreciation/amortisation rates used for each class of depreciable assets are:

Class of Property, plant and equipment Plant and equipment

Depreciation rate

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the incorporated association. Gains and losses between the carrying amount and the disposal proceeds are taken to the statement of comprehensive income.

Depreciation has not been applied to Buildings which are located on land registered in the name of the Club.

(g) Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount:

Recoverable amount is the higher of an asset's fair value less costs to sell and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

(h) Trade and other payables

These amounts represent liabilities for goods and services provided to the Club prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

(i) Inventories

Inventories consist of bar and apparel stock and are measured at the lower of cost and net realisable value. Costs are assigned on a specific identification basis and include direct costs and appropriate overheads, if any.

(j) Employee benefits

Provision is made for the Club's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits expected to be settled within one year together with benefits arising from wages and salaries, annual leave and long service leave which will be settled after one year, have been measured at their nominal amount. Other employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits.

Contributions are made by the Club to employee superannuation funds and are charged as expenses when incurred.

(k) Goods and Services Tax ("GST")

Revenues, expenses, and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office.

In these circumstances the GST is recognised as a part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the Statement of Financial Position are shown inclusive of GST, where GST applies.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

(I) Comparative figures

Where required by Accounting Standards, comparative figures are adjusted to conform to changes in presentation for the current financial year.

(m) New, revised or amended Accounting Standards and Interpretations adopted

The Club has adopted all the new and revised Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for a charity or not-for-profit entity registered with the Australian Charities and Not-for-profit Commission during the current reporting period. The adoption of these new and revised Accounting Standards and Interpretations has not resulted in a significant or material change to the Club's accounting policy.

INDEPENDENT AUDITOR'S REPORT ON THE FINANCIAL REPORT TO THE MEMBERS OF COTTESLOE SURF LIFE SAVING CLUB INC

Qualified Opinion

We have audited the attached special purpose financial report of Cottesloe Surf Life Saving Club Inc. ('the Association), which comprises the statement of financial position as at 30 April 2022, statement of profit or loss and other comprehensive income, statement of changes in equity and the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the declaration by the members of the committee.

In our opinion, except the matters mentioned in the "Basis for Qualified Opinion" Section of our report, the accompanying financial report of Cottesloe Surf Life Saving Club Inc. is in accordance with *Division 60 of the Australian Charities and Not-for-profits Commission Act 2012 including:*

a) Giving a true and fair view of the Association's financial position as at 30 April 2022 and of its financial performance and cash flows for the year then ended; and

b) Complying with Australian Accounting Standards disclosed in Note 1 to the financial report.

Basis for Qualified Opinion

Existence of Inventory

We noted that the Association has an inventory of \$ 22,211 at 30 April 2022, due to the time restriction, we did not attend the stocktake at 30 April 2022. Therefore, in the absence of the physical stocktake, we are unable to determine the existence of inventory at 30 April 2022. Consequently, we are unable to provide opinion on the existence of inventory at 30 April 2022.

Land and Buildings

As disclosed in Note 8, the Association has \$669,485 in land and buildings at 87 Marine Parade Cottesloe WA. We were unable to obtain sufficient evidence to verify the cost of the land and building stated in the financial statements and we have observed that the buildings component has not been depreciated in accordance with AASB 116 Property Plant and Equipment. Therefore, our audit report has been qualified in respect of this matter.

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of the Group in accordance with the auditor independence requirements of the Australian Charities and Not-for-profits Commission Act 2012 and the Accounting Professional and Ethical Standards Board's APES 110 Code of Ethics for Professional Accountants ("the Code") that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code. We confirm that the independence

Without modifying our opinion, we draw attention to Note 1 to the financial report which discloses the basis of accounting. The financial report has been prepared to assist the Association meet the requirements of the *Australian Charities and Not-for-profits Commission Act* and to meet the needs of members. As a result, the financial report may not be suitable for another purpose.

Responsibilities of Committee Members for the Financial Report

The Committee of the Association are responsible for the preparation and fair presentation of the special purpose financial report that gives a true and fair view and have determined that the basis of preparation described in Note 1 to the financial statements is appropriate to meet the requirements of the *Australian Charities and Not-for-profits Commission Act* and is appropriate to meet the needs of members. The Committee are also responsible for such internal control as the Committee determines is necessary to enable the preparation of the financial report that is free from material misstatement, whether due to fraud or error.
