Objectives of the Club

To promote those objectives endorsed by Surf Life Saving (WA.)

- a) To promote and enforce the work of the Surf Life Saving Association, the resuscitation of the apparently drowned and the application of first aid on the beachfront between Cable Beach, Mosman Park and Napier Street, Cottesloe.
- b) To carry out patrols in accordance with the regulations of Surf Life Saving (WA) and provide the necessary efficient life saving equipment.
- c) To co-operate with other organizations in enforcing life saving methods and equipment.
- d) To educate the public surf awareness and current resuscitation procedures and encourage members of the public to gain awards as permitted by Surf Life Saving (WA).
- e) To partake in competitions and events in all surf life saving areas and other areas permitted by Surf Life Saving (WA) and to sponsor members to complete.
- f) To co-operate with the Town of Cottesloe in possible improvements to beach facilities.

In Addition:

- a) To acquire by purchase, exchange or otherwise whether for an estate in fee simple or for any less estate lands and tenements or real personal property or any tenure thereof, whether subject or not to any changes, or encumbrances, and to erect, replace, maintain, reconstruct, adapt and furnish any offices, buildings, or lands, tenements or property or any part thereof after approval by a Club General Meeting.
- b) To borrow any monies required for the purpose of the Club upon such terms and conditions as may be determined and for that purpose to mortgage, pledge or otherwise charge any real or personal property of the Club.
- c) To invest funds of the Club, when available, providing that investments shall be in trustee securities only.
- d) To employ staff as required to administer and promote the objectives of the Club.
- e) To do all or any of the matters authorized either alone or in conjunction with any person, company or unincorporated body through any factors, trustees or agents.
- f) To do all such things as they appear to the Club to be incidental or conducive to the attainment of the foregoing objectives or any of them.

Geoffrey Maurice Brown OAM

21st December 1929 - 19 August 2017

Geoffrey Maurice Brown OAM was colossus of Surf Life Saving both here in WA and on a national basis, recognised by both with State association 1969 and national 1975 Life membership, as well as being honoured by her majesty with an OAM. These honours in no way detract from his Life membership of our great club Cottesloe in 1962, where he started his massive surf lifesaving career and a club he loved with a passion, to which he gave his heart and soul. Where does one start and how do you cover a lifetime dedicated to his two passions, Surf and the Claremont football club, where he played seconds football with some of the greats of that club.



It must be said, that his attention to detail and his ability to recall dates, was to say phenomenal and often left us gasping in wonderment. So much so, that following his compiling of Cottesloe's list of bronze holders from day one, he took on the task of compiling the same for each WA club. Upon hearing this at the national level, National council requested that he update their records, which he did with little fuss much to the wonderment of those in charge.

Born to Maurice and Isabelle Brown in Subiaco as a New Year gift, he returned with his parents to Kookynie and Minnivale where his father was a school teacher. Geoff was an only child and he completed his primary school at Cottesloe Primary, Junior certificate at Fremantle Boys, where he was school captain, and his Leaving certificate at Perth Modern School along with class mate Bob Hawke.

Upon leaving school Geoff joined Burroughs Adding Machine Company where he worked until retirement. Cottesloe and Bunbury Surf Clubs had a close rapport, Geoff was a regular attendee at Bunbury's annual dinner, which were held at the Burlington Hotel. There he met receptionist and Bunbury club member Joan Wakefield. They were married in 1967 and set up home in Brix Street Wembley Downs, a spot that was to become a "half way" house especially when they purchased the first TV set. They later moved to Maisie Street in the early 70's which continued to be a "half way" house and in later years the site of compilation of envelopes and Waveline newsletters for the Cottesloe Vets. His meticulous detail to ensure the correct number of envelopes prevailed.

Surf Life Saving was to become Geoff's life from the day he joined Cottesloe Surf Club as an 11 year old in 1941. He obtained his bronze 24082 on 8th December 1946 & instructors Certificate in 1948. Geoff recalled to me an early exposure to surf rescue when, from the car park, he spotted a lad in trouble about 70 metres from the beach beyond the reef. Despite his many tales of his ability in the surf, Geoff was not a particularly strong swimmer. However this did not deter him from risking his own life to bring the lad safely back to the beach.

At school he showed promise as a track athlete and went on to have some considerable success as a beach sprinter winning titles in beach relays. His running ability meant he was a prime target for Don Morrison when he was putting together his belt race reel team, helping him to win three Australian titles. Geoff took great pleasure in letting everyone know that he rowed boats, competed in R & R teams along with coaching the team that won the state titles.

In his 76 years at Cottesloe he served in every management position from secretary to captain and as President for nine years. He also was manager of the Australian team that toured to Cornwall in 1970 to compete in the world titles.

Geoff's greatest delight was in telling how following one of his many visits to the eastern coast, both for business and with touring state teams, he witnessed the setup of the helicopter service on the east coast and the wonderful work they were performing. Upon returning home he wrote a paper to Surf Life Saving WA promoting the idea as appropriate to WA. Commencing in 1980 the service flew some 39 missions, with Geoff as part of the crew, until 1985. With sponsorship, the service grew over the years to become what is now standard practice each summer, a great testament to his foresight.

As we all know, Geoff could not stand still in Surf Life Saving so in 1994 he was, along with Lyal Dedman, Ron Kidner, Jack Rowse, Malcolm Till and Ray "Paddy" Redfern, the initial committee of the Cottesloe Vets, "the Vets" as we know it today. Geoff held the position of Registrar from then until his death and was almost solely responsible for collating the list of members we have seen over the years, keeping meticulous records of new members, members who have joined and left, members who have gone before us. How do you replace that?

Richard Anthony Arthur (Dick) Rose

21st January 1927 - 24th March 2018

Richard Arthur Anthony Rose, known as Dick was born in Perth in January 1927 to parents Henry and Cynthia. He did his secondary schooling at Fremantle Boys. He had a happy and carefree childhood, spending his spare time at Cottesloe beach, and if not there he would be kicking a football around with his mates. Both of these pastimes, the beach and footy, were constant themes throughout his life and he retained a strong interest to the end.

Dick joined the club in 1943 and obtained his bronze no. 20091 on 12 December 1943.

He played football for Claremont in the under-age competition that was set up during the war years. A stylish left footer, he referred to himself as 'the rugged rover Rose' when telling his boys of his match winning deeds - we suspect some of the stories may have been embellished with the passage of time.

He joined the Navy as soon as he could in 1945 and sailed out of Fremantle on what he called the victory lap, with the war ending before they got to Sydney. Having made only the one voyage he was demobbed in 1947. After his round the world trip with the Navy, he returned to Perth and resumed his love of the beach and Cottesloe Surf Life Saving Club, where he became the youngest President (at that time). In his words, he said it needed a bit of a shakeup and to get the young blokes involved. He led a leadership coup but was surprised when they won.

About this time he met a young nurse named Connie whom he would marry and she would remain the love of his life until her passing in 2014. Even after moving away from Perth in the 1980's Dick's involvement with the Cottesloe Surf Club remained a defining aspect of his life and identity, one which he frequently recalled with much affection.

He had a long and successful career in Insurance, firstly in Perth and later in Darwin. Dick and Connie had six children and they retired to Melbourne to be closer to Connie's family. In Melbourne he had a second career as a crosswalk lollipop man & where he manned the same crossing for 20 years and loved every day.

Dick was a 'people person'. He loved talking to whoever he was with & was a good listener who took a genuine interest in what the other person was doing or thought. He made friends easily and was very sociable. He passed away peacefully in his sleep at the age of 91, and in his own words, he 'had a good innings'. He is survived by five children, 11 grandchildren and eight great grandchildren.

Richard (Dick) Henry Hartley

6th September 1926 - 23rd September 2017

Richard Henry Hartley grew up in John Street Cottesloe and went to Cottesloe Primary then Fremantle Boys School. His knowledge and memory of the Cottesloe area was staggering. He did have the advantage of being a postie delivering letters and telegrams in the area but he knew who lived in every house in almost every street. This of course was back in 1942-43. Only last year he helped the Cottesloe library by recalling all the businesses and their owners in Napoleon St back in the 40s and 50s.



He left school at 14 to work with Australia Post for the next 44 years. He went from telegram boy to postie then to Transport. He was moved to the mail exchange, as sorter, then supervisor to eventually shift controller. Dick served in the Postal service in Kalgoorlie for a number of years also. Of course Australia Post was just one job. When the children were young growing up in Mt Claremont, Dick and Eileen went off on weekend mornings to clean offices. During the week, because Dick always worked shift work, he had a burgeoning lawn mowing round. He only sold it when Eileen started running amok with her Tupperware and he helped with orders and packing. The garage was always jammed packed with boxes waiting to be delivered. Dick never complained or said he was tired. He did what he had to do to make a good life for the family, all the while continuing his training regime.

Dick saw service in the army during WWII. Living in John Street opposite Graeme Teague Dick joined the Surf Club in 1943 obtaining his bronze no. 20092 on the 12th December 1943 and was awarded Life Membership in 1963. During his time in Kalgoorlie, Dick competed in the State Still water championships held there, swimming a close second to Olympian Garrick Agnew, in the 220 yard event. Also in this event was the notorious Ralph Harris, an excellent swimmer in his own right. Dick was to win some 19 state surf titles and two water polo titles, along with numerous swim thru events during his career.

During his 30's and 40's it was all about working and raising a family. In his spare time though, he loved to hit golf balls and kept his hand in at swimming. But his main pastime and passion was golf, as a member of Seaview Golf club, where his name appears as winner on the Summer Cup honour board. He had a handicap as low as 8 and knew how to work the ball with and against the howling Cottesloe sea breeze. On the par 3, 4th hole, you could hit a 9 iron in the morning and on the same hole have to hit a 3 wood in the afternoon. In later years he and Eileen joined Wanneroo Golf Club. A longer course than Dick was used to, he had to lose the big fade in order to gain length on the fairways. Of course he was able to adapt to this and would go on to shoot his age, carding a 78 off the stick when he was 80, only 11 short years ago.

Dick played all sports including Aussie Rules and some rugby even cracking one league game with the Claremont Tigers, but it was Cottesloe Surf Club where he left his mark winning multiple Surf titles and belt races and Australian titles too numerous to list. One wonders where his swimming gifts would have taken him, if he'd had the opportunities of top coaching, as he never had a swimming lesson in his life and always trained alone. Dick's son Alan relates a family story of Dick's sportsmanship *'when during a swim through Perth, Dick was once again up against one of his staunchest of rivals and fellow club member, Don Morrison. During the race the course had a deviation of some kind requiring the swimmers to swim in a certain direction. Don and Dick were neck and neck when Don started veering off course. Dick yelled to him as to the correct direction to take. There was no debate in my father's mind as to the right thing to do. I don't even know the outcome of that race because the story went more to the character of the man than the result. As an aside to this for those of you that knew my mother, she .couldn't fathom why he would want to point his arch rival in the right direction. Who would do that? Dick would'*.

The Premier Club book lists Dick some fifteen times, outlining his team participation in Surf Teams and R&R, during which he often forsook his individual chances to win individual events to help the team. This was also evident when he took-part in the forming and development of the "Surf" water polo club, when he could have won premierships with stronger clubs. Known to all as "Uncle Dick" and as a junior I recall his helping hand with my own swimming, R&R and water polo-development, nothing was too much trouble for him. In later years we enjoyed our time together in the pursuit of Winter Swimming with "the Bears", where Dick set many State Australian and world records in the various age groups. Unfortunately we do not have the space to do true justice to Dick's life, career and sporting achievements; we have lost one the "GREATS" in WA swimming and Surf Life Saving.

In Club tradition, President Ben Stephens declared the bar open.

President Report

Dear Members,

It's with pleasure I present the 108th Annual Report of the Cottesloe Surf Life Saving Club (Inc.) on behalf of the Management Committee of 2017/18.

While the last 18 months can undoubtedly be described as a difficult period for the Club, I am heartened by the resilience that ensured we stayed positive, focused on our objects and delivered a season where no lives were lost on Cottesloe Beach.

The dominate issue of the last 18 months relates to the recent legal matters the Club has faced, and for the benefit of posterity I record the central portion of my recent email to members in this report:

"As detailed in my email to you on 14/02/2018, the Club was charged in January 2018 with two offences under section 22(3) of the Working with Children (Criminal Record Checking) Act 2004. A hearing in the Magistrates Court on 14 February 2018 was adjourned to allow the Club's lawyers to provide further advice to the Management Committee.

This morning at a hearing in the Magistrates Court, the first charge was discontinued by the Prosecution and, on the advice of the Club's lawyers, Cottesloe Surf Life Saving Club entered a plea of guilty to the second charge.

The second charge relates three mornings; Sunday, 5 February 2017, Sunday, 19 February 2017 and Sunday, 19 March 2017, where specific tasks were undertaken by a long standing member who held a current Negative Notice issued by the Department of Communities. Those tasks included operating an inflatable rescue boat, securing buoys in the water to be used during Club activities, and setting up before and packing away after Club events and activities, including a nippers' junior marathon. In the undertaking of these tasks the member had access to Club's boatshed and equipment, at the same time that children also had access the Club's boatshed. As such his usual duties involved or were likely to involve contact with a child, which is a breach of the Act.

The prevailing view has been members who deliver direct services to children such as age group managers, coaches and instructors, are required to have a Working with Children card, unless exempt - such as they are under 18 themselves or a parent in the same activity.

As a result of this case we are seeking guidance on the application of a Working with Children Check on any adult involved in undertaking duties at the club I want to assure you that this is an isolated issue which has stemmed from the interpretation of child-related work and record checking compliance. It is not the result of any instance of harm against a young Club member or visitor."

While the court process was what consumed the past 6 months, the situation started in earnest in April 2017 when the Department of Communities launched an audit and concurrent investigation dealing the Club's child protection approach generally and specifically the response to a letter received in January 2017 indicating that a long term member had returned a negative notice on application for a Working with Children Card.

It has been a difficult process to navigate and I would like to thank all those involved, but particularly the Management Committee that volunteered their time from July 2017, knowing this matter was afoot. I would particularly like to thank Nic Blackburn and Peter Ferguson for their efforts in this matter.

For me the above issue has been a bit like staring at the sun - it dominates your vision and then when you look to other things there is residual "blurred vision, dark or yellow spots, pain in bright light or loss of vision in the center of the eye"... Thankfully, due to some stalwart efforts we are still able to record some great successes across the season.



President Report (continued)

At the most inspirational level was Steve Plain's super-human effort to climb the seven peaks on seven continents. '7-in-4' was captivating viewing on social media, where we saw the Cott competition cap scaling the heights together a patrol flag to raise awareness for Surf Life Saving and spinal rehabilitation. Steve's success is an 'icing on the cake' moment on what was already a great story of Gary and Lara Matier's earlier morning rescue on their way to a carnival. I would like to acknowledge their fantastic rescue again, also thank David Hounslow for his support of the project last year and let's not forget Leesa Matier social media efforts!

Another standout for me this season was the fundraising efforts across Sculpture by the Sea. This was not, just because of the great financial return to the Club, but because it was great seeing many different areas of the Club taking responsibility for a weekend day and working together to achieve a positive result. Amongst the many helper I will acknowledge Pete Ferguson and Sam & Stuart Cowie for their thousands of steps from between boatshed and clubhouse and Owen Ashby and his onion slicers.

The Junior Activities area was again professionally run by Glenn Eldon, even more so this season due to the largely vacant Youth Development Position. Glenn had his list of task and went about delivering on them with minimal fuss and the outstanding support of a dedicated team of Age Group Managers. I extend my thanks to them all.

James Jenkin stepped in part way through the season as Lifesaving Officer and was a much needed experienced set of hands in supporting the Patrol Captains and education efforts. Lifesaving is our core focus, and while there are many challenges - most of which have been articulated in annual reports going back 40 plus years - is through the calm, persistent leadership of people like James and his team of Patrol Captains that we continue to provide for the safety of the public at Cottesloe Beach.

The Australian Titles being hosted in Scarborough this season provide a great focal point for Surf Sports and across the juniors, open and masters competitors medals were returned of all hues. Surf Sports is an integral part of surf lifesaving, aiding as it does in surf skills and fitness to support the patrol side of things - but also provide a great opportunity for the demonstration of Club Spirit, which was evident from weekly training through to supporting other competitors at the Aussies. Thanks to Peter Ferguson and Jason Landwehr and all the coaches, handicappers and captains for a great season.

In the support services side of the Club we see another great year delivered by Owen Ashby and his sausage and coffee team as well as rolls and such from Leesa Matier and Jan Stephens (aka mum). Leesa has also delivered another great season of Friday Food Trucks, with the ever present decorating talents of Jo Suda making it happen on Fridays and social occasions.

Thanks also to David Craig and his building committee - they maintained their focus on working through to a plan for much need work on the clubhouse and I'm confident it will all come together with a minimum of blood.

Peter Berry and his finance committee, together with the sponsorship committee provided conscientious service to the Club in many of the truly backroom tasks - thanks all.

Administratively I extend my thanks as always to Ditte van der Linde and Margaret Bond. Left to its own devices administering this Club would be like the boulder scene in Indiana Jones and the Raiders of the Lost Ark. Thanks to Ditte and Marg it's a little more controlled.

I decided not to continue in the role of President in 2018/19 - let's say so as to regain my sight - and so we will welcome Mike Franz as the incoming President. I wish Mike all the best in what is not the easiest of roles, but one I feel he is eminently suited.

Deputy President Report

The 2017/18 season posed many challenges amongst them is the perpetual quest to create a cash positive hall hire and bar. A number of strategies were undertaken however in the end I believe there are three main issues with this revenue stream:

1. The market for venue space of our size (150-200 people) is highly competitive and dominated by full service restaurants and bars.
2. The investment in staff and marketing to establish this revenue stream seemingly negates the additional revenue received
3. There are a number of competing demands for both the hall space and resources within the club. The most valuable resource being volunteer time can be used with little or no gain in the development of the hall.



We would therefore recommend that the future pursuits for revenue come either from an organic member support for the bar or full commercial outsourcing. An example of this that has been successful is the excellent work of the Friday night food trucks team and the café on Sundays and throughout the week.

Major renovations and work on the building have been put on hold as the building committee prepares to bring forward large scale renovations. The day-to-day maintenance continues to be undertaken by a dedicated and consistent group to which all members of the club remain indebted.

The vast majority of my time and attention this year has been on the criminal court proceedings brought against the club by the state solicitors office. I am pleased to say that we have resolved this issue and we look forward to improving our processes and knowledge retention. This suit has highlighted the need for improved understanding, record keeping and state wide processes from government enforced regulation. I would caution any member of complacency and stress the importance of trusting the Management Committee, as they are ultimately responsible. It can be easy to pass comment without full knowledge but it is imperative that members trust the Management Committee to make decisions in the best interest of the club beyond the here and now.

I will not be standing again and wish the incoming committee the best of luck moving forward.

Treasurer Report

This year the Club performed far better financially than last year. The Club returned a surplus of \$15,116 and an increase in cash balances of \$121,519. There are a number of reasons for the large difference between surplus and change in cash balances - depreciation of assets, the provision for legal expenses, apparel stock write downs and timing of sponsorship revenue and receipts - but ultimately it is cash available that is the most important financial number to the Club.

To highlight some details, the Café continues to be excellently managed and is very profitable, membership fees levelled off after falling in the previous two years, there was a large change in the performance of the bar after posting a significant loss last year, apparel shop sales increased, Friday night activities continued to be popular, the Cottesloe Mile was a huge success as always and the Club received the benefit from the Foundation higher interest term deposits that were set up last year. In terms of operating costs there were some small variances compared to last year but in total costs were similar.

The Club held \$266,467 of cash at the end of the year. The Foundation itself surpassed the half million dollar mark, growing by \$35,212 to \$512,628. These very strong and healthy cash balances will set the Club up very well financially for the future.

The financial highlight for the Club this financial year was the fundraising effort during Sculptures by the Sea. Over the three week period this delivered a cash profit to the Club of around \$20,000. There are too many names to mention them all here but loads of people helped out be it organising, sourcing meat, bread and other items to sell, manning the sausage sizzles and ensuring that the café was open every day. This was a monumental effort by all and shows what can be achieved when we are focused and committed as a Club. The Treasurer's Report in last year's Annual Report alluded to this so it was great to see this reach fruition.

I would like to acknowledge Peter Berry for all the work that he has done as the Club Treasurer over the past two years or thereabouts and thank him for his time and effort. I took over the role as Treasurer on 28 February 2018.

I am sure with continued focus, mutual endeavours and persistence the Club will continue to prosper in future years.

Club Captain Report



This season has been one of many highs and achievements and has also involved unique complex challenges that have required careful management and considerable time and effort from a number of people. This has mostly occurred in the background, out of sight and quietly.

I would like to sincerely thank Nic Blackburn for his patient perseverance and maturity beyond his years in dealing with the matters currently before the courts. I have said to Nic several times this season, if he chooses to, he has the ability to shape and lead our community.

At times this season I have asked the question: what brings each of us to our club, why do we stay through the ups and downs, the thick and thin, and return year after year? I know some of the usual responses include: 'to protect and save lives, to serve our community', however there have been times this season when these responses have raised more questions than they answer. I believe our purpose

is to work together to build, develop and sustain a sense of community. That is, our club should be a place where each member feels they belong, where all members matter equally to one another and to the group, and where the needs of every member are met through their commitment to being together.

A good example of this is Sunday morning activities which at different times during the season involves every member and every area of our Club. Everything flows seamlessly on Sunday mornings and we all appear to be relaxed, happy and enjoying each other's company. This is from the dedicated and reliable people on patrol; members training for awards and requalification; Glenn Eldon, his team and the Nipper Army; our wonderful Vets doing their Sunday morning swims; Danny and Chad's water safety; to the Boaties training and/or recruiting rowers; Owen's fantastic Café and Sausage Sizzles; Jan Stephens patiently making rolls in the kitchen; Water and Beach events; Marg Bond in the office & Justine Savage & Rita Swaine in the Apparel shop; the list goes on.

If you have been to the Club on Friday evenings you will also have seen what I describe as our Community in action, with Leesa's food trucks, the Leavo's stubby stakes, Jason's beach training, special events such as St Patrick's Day Irish Dancing, board training and more.

To guide and develop our young competition focused members, this season we launched the High Performance Academy. Under the expert guidance of Ian Cook this model will continue to shape and develop our young people who are selected to participate in the Academy.

Our seven Sausage sizzle fundraisers during Sculptures by the Sea, that took a bit of practice, which involved almost 100 of our members aged from 14 to over 70 working together to raise over \$25,000 for our Club, is another example our community in action.

Our Club also enjoys a broad membership base of over 1000 people from a range of backgrounds and experiences. Interestingly many do not live in the Western Suburbs and some travel significant distances to be a part of our community and to participate in Club activities.

On the theme of travel the Aussies are an occasional visitor to Western Australia, with this year being the latest visit, following their last trip across the Nullarbor in 2014. Once again the involvement of our Club in this iconic event had a community feel. Examples included Jim Laurensen's bus service provided by the Vets, parents and coaches working together supporting our competitors, and various members officiating, providing water safety and commentating. Interestingly this year, with our members competing in fewer events in comparison to 2014, our medal total of 21 was the same, and pleasingly we won 4 more gold medals than when the Aussies were last held in Western Australia. I also need to acknowledge the patient efforts of Ditte Van Der Linde in dealing with the Chameleon that was the Aussies Cert 11 process.

Now to some important statistics from the season. Our Patrolling members performed 36 rescues, 581 preventative actions and completed 6667 patrol hours. 36 members were awarded their Bronze Medallion and over 34 completed their Surf Rescue Certificate. Our patrol members were also involved in supporting and working with our colleagues from North Cottesloe Surf Life Saving Club in saving the life of a young man who had collapsed from a heart attack while running along the beach between our Clubs.

Club Captain Report (continued)

As some of you will be aware Surf Lifesaving Australia provides important grant funding through the Beach Safety Equipment Fund and this season we have been able to replace and acquire essential lifesaving equipment including rescue boards, state of the art oxygen therapy equipment and rescue tubes.

We also replaced our aging All Terrain Vehicle with a new SSV (side by side Vehicle), but the coolest and potentially most important acquisition was a Phantom 4 Drone which in coming seasons will be used for aerial surveillance. Congratulations to the two Cottesloe SLSC Drone Operators, Douglas Simpson & Addison Ogg, who were finalists in the SLSWA Awards of Excellence Support Operations Volunteer Award.

I hope you now have a sense of the important role our Club has in the community and the contribution we make across a broad range of areas. Our future looks promising, for example we have plans for Refurbishment of the Clubrooms, including the Gym, which are currently in the concept phase. To bring this project into execution will require significant effort and fundraising through the generous support of a broad range of people and organisations.

My final comment on the season is more of a request for the future. That is for each of us to regularly step back and take time to think and reflect. Think about your place in our community and understand that it is about more than you, your child, your family, and your friends. Reflect on the example your behaviours are setting and the contribution you are making to building, developing and sustaining a sense of community at our Club. To try to put others first and be accepting, tolerant and kind to the people around you and who you interact with.

My parting hope is for our club to be a community where people choose to spend time with their family and friends, to become everything that is a surf lifesaver, to patrol, to train, to compete, to socialise, and most importantly, to come back to.

Australian Championships

The O/65 Double Ski saw last years silver medallists Stan Davies and Rob Slattery have a comfortable win leading the whole way and claim the Gold Medal. In the Board riding Stan Davies won a Gold Medal in the Short Board O/60yrs and a Bronze Medal in the Longboard O/60yrs. Lifesaving Report

The 2017/18 season saw the accumulation of 109 years of service to our community. Whilst much has changed over the years the core mission remains the same, this year we completed 6,668 patrol hours, continuing the trend of a small decrease in hours over the past few years. I thank each of our 14 Patrol Captains for their commitment and support in delivering on our commitment to the provision of quality lifesaving services.

Supporting our Patrol Captains were the members of the Lifesaving Committee and I thank each of those for the support they have given me and our members during the season. The Lifesaving Committee had a number of changes to key personnel and this contributed to some of the challenges during the season. I would particularly like to thank Ben Stephens and Stephen Goddard for their support and assistance with the education program.

Rescues were also down this season with 36 recorded, all with successful outcomes. More than 60% of those rescues occurred during afternoon patrols. One rescue, not officially recorded, involved an adolescent penguin whom had become lost and was exhausted. A member of the public had found the penguin at Cables just south of Cottesloe and knowing lifesavers would be on duty transported the patient to Cottesloe and into our care until we were able to transfer to the Department of Biodiversity, Conservation and Attractions, who happened to have a Wildlife Officer in the area at the time.

In the later part of this season we participated in the inaugural drone surveillance patrol program that saw the deployment of drones to six clubs along the coast. The resident Phantom 4 drone at Cottesloe is used by Lifeguard Services during weekdays and by trained club members during the weekend. This is an exciting new dimension that complements our existing surveillance operations through the provision of amazing clarity of the crystal-clear waters at Cottesloe. During the off season and into the 2018/19 season we hope to continue to train members to pilot these craft and I expect surveillance flights will significantly increase over the coming summer as more members become qualified pilots.

We also replaced the All-Terrain Vehicle (ATV) now known as a Side By Side vehicle and through the provision of the Beach Safety Equipment Fund (BSEF) have invested in the replacement and acquisition of new lifesaving equipment.

Finally, I would like to thank all members that assisted over this past season and wish the incoming Lifesaving Committee continued success for the season that awaits them.

- Profit from the Café has again topped \$25,000 in line with expectations. See audited accounts for the exact figure. Profits from the Café since the initial coffee machine was installed have exceeded \$250,000.



The Cott Pylon Café has not only provided another substantial income stream for the club (see accounts report), it has provided members of an all year meeting place to socialise and utilise club facilities. The club which is grossly underutilised gives gymnasium users a reason to stay for a coffee and a chat on opening days.

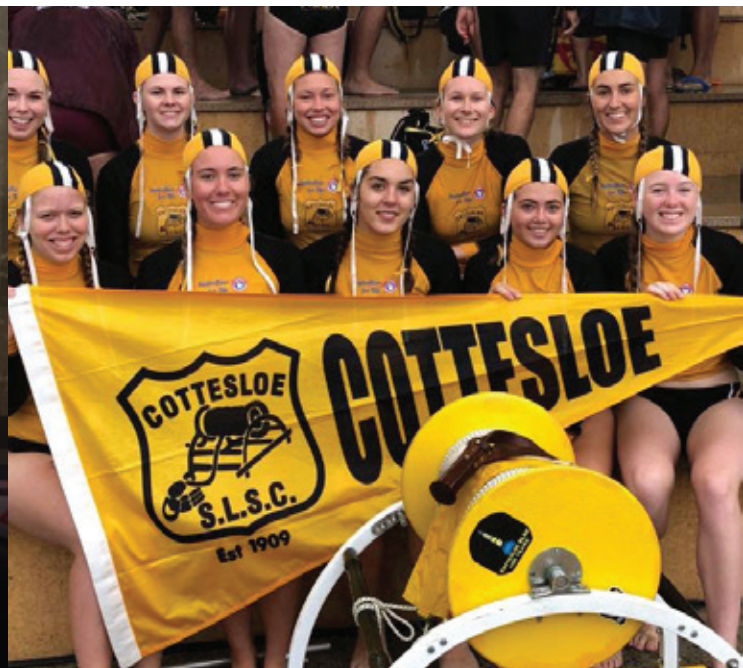

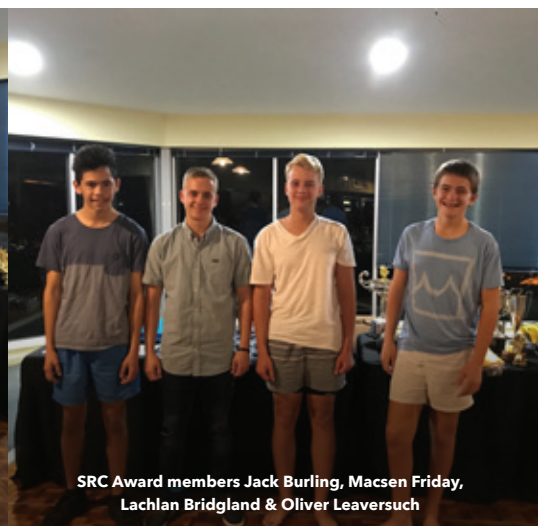

1 STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial report covers the Cottesloe Surf Life Saving Club (Inc) ("the Club") as an individual entity. The financial report is presented in Australian dollars, which is the entities functional and presentation currency.

The financial report consists of the financial statements, notes to the financial statements and the officers' declaration.

Basis of Preparation

This financial report is a special purpose financial report prepared for use by the Management Committee. The Management Committee has determined that the Club is not a reporting entity.

These special purpose financial statements have been prepared in accordance with Australian Accounting Standards applicable to entities reporting under the Associations Incorporation Act (WA) 2015, Charitable Collections Act 1946, Australian Charities and Not-for-profits Commission Act 2012 and Australian Charities and Not-for-profits Commission Regulation 2013 and the significant accounting policies disclosed below, which the Management Committee has determined are appropriate to meet the needs of members. Such accounting policies are consistent with the previous period unless stated otherwise.

Historical cost convention

The financial statements have been prepared under the historical cost convention.

Critical accounting estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also requires the Management Committee to exercise its judgment in the process of applying the entities accounting policies. There are no areas identified involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the financial statements.

(a) Accounting Policies

The principal accounting policies adopted in the presentation of the financial statements are set out below. These policies have been consistently applied to all years presented, unless otherwise stated.

(b) Revenue recognition

Revenue is recognised when it is probable that the economic benefit will flow to the Club and the revenue can be reliably measured. Revenue is measured at the fair value of the consideration received or receivable.

Membership fees

Membership fees are recognised on receipt in the period covering the surf life saving season of activity, i.e. October to March.

Donations

Donations are recognised at the time of receipt.

Interest

Interest revenue is recognised on receipt.

Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

(c) Income tax

The Club is exempt from income tax under the provisions of Section 50–5 of the Income Tax Assessment Act 1997.

(d) Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less.

(e) Trade and other receivables

Other receivables are recognised at amortised cost, less any provision for impairment.

(f) Property, plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

The carrying amount of plant and equipment is reviewed annually by the Management Committee to ensure it is not in excess of the recoverable amount from those assets.

The depreciable amount of all plant and equipment is depreciated on a straight line basis over the useful lives of the assets to the Club commencing from the time the asset is held ready for use.

1 STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The depreciation/amortisation rates used for each class of depreciable assets are:

Class of Property, plant and equipment	Depreciation rate
Plant and equipment	20%

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the incorporated association. Gains and losses between the carrying amount and the disposal proceeds are taken to the statement of comprehensive income.

Depreciation has not been applied to Buildings which are located on land registered in the name of the Club, under a Crown Grant.

(g) Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs to sell and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

(h) Trade and other payables

These amounts represent liabilities for goods and services provided to the Club prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

(i) Inventories

Inventories consist of bar and apparel stock and are measured at the lower of cost and net realisable value. Costs are assigned on a specific identification basis and include direct costs and appropriate overheads, if any.

(j) Leases

Lease payments under operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

(k) Employee benefits

Provision is made for the Club's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits expected to be settled within one year together with benefits arising from wages and salaries, annual leave and long service leave which will be settled after one year, have been measured at their nominal amount. Other employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits.

Contributions are made by the Club to employee superannuation funds and are charged as expenses when incurred.

(l) Goods and Services Tax ("GST")

Revenues, expenses, and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office.

In these circumstances the GST is recognised as a part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the Statement of Financial Position are shown inclusive of GST, where GST applies.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

(n) Comparative figures

Where required by Accounting Standards, comparative figures are adjusted to conform to changes in presentation for the current financial year.

(o) New, revised or amended Accounting Standards and Interpretations adopted

The Club has adopted all the new and revised Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for a charity or not-for-profit entity registered with the Australian Charities and Not-for-profit Commission during the current reporting period. The adoption of these new and revised Accounting Standards and Interpretations has not resulted in a significant or material change to the Club's accounting policy.


